



## Financial Affidavit

Before Central Community College (CCC) can issue a "Certificate of Eligibility for Nonimmigrant Student Status" (SEVIS I-20) for a student visa to enter the United States, the applicant must have an official admission offer to enroll and must provide the following documentation.

- If the student, student's parents, spouse, relative, friend, etc. will fund the student's studies at CCC, the student must provide an official bank statement showing the availability of the required amount in U.S. dollars AND this Financial Affidavit form. Bank statements must be no older than six months and in English. This form can be substituted with a letter from the sponsor declaring intent of sponsorship or an official, stamped letter from the bank stating the availability of the required amount in U.S. dollars.
- If the student will be sponsored by a government agency of a public or private institution, the agency must provide official certification that the appropriate costs will be covered.

**Note regarding official documents:** CCC must have the original or certified copy of the original Financial Affidavit and bank statement in order to issue the form I-20. Since the student may need to provide the same information when applying for a student visa, it is recommended that the student obtain duplicate certifications or provide CCC with certified copies. Photocopies that are not certified as true copies of the original will not be considered as acceptable proof of financial support.

### Section 1. Statement of Financial Support

The total expense for an unmarried international student is estimated to be **\$19,180.00** for a twelve-month academic year. Living expenses during the 3-month summer period and the cost of optional summer classes are included. A married student who is accompanied by spouse and children will have considerably greater expenses. Sources and amounts of financial support for each year will be provided in the following manner:

**Section 2. Oath of Sponsor showing support** *(to be endorsed by individual promising personal or representative promising government or agency sponsorship).*

This affidavit is made by me for the purpose of assuming the U.S. Government that the person named above will not become a public charge of the United States. I understand this form may be made available to any Federal, State, or local agency that may receive an application from the above and/or their dependents for various government subsidies and that my income and assets may be considered in deciding the individual named above and/or individual's dependent's application(s). I understand that by endorsing the affidavit I am obligating myself, or my government or agency as its representative, to make the current minimum sum of expenses estimated by CCC for I-20 purposes available to the student. I certify under penalty of perjury under United States law that I know the contents of this affidavit signed by me and that the statements are true and correct.

I am attaching a CURRENT and OFFICIAL statement from my bank attesting to my financial status, with the name of my bank \_\_\_\_\_ OR I have attached the Form I-134 and have sent a copy to the student. I hereby guarantee without reservation to maintain and support above mentioned student with education costs and living expenses while this student is enrolled at Central Community College. I understand that the applicant, if accepted at Central Community College, will be a full-time student who may not accept off-campus employment unless permission is granted by immigration. This permission is difficult to obtain and must not be assumed to be available.
