Notes: Faculty members are entitled to receive \$6,300 if they are assigned a voluntary paid overload teaching of a one semester course that has three (3) hours or less. \$6,300 stipend may be pro-rated accordingly for shared teaching arrangements; if a faculty member teaches a course in part as a replacement faculty member; if overload teaching semester hours exceed three (3); and for CUPE Local 3904 Unit 1 Contract Lecturers' overload teaching.

An overload in YSGS requires approval from the Vice-Provost and Dean, YSGS as well as consultation with and approval from the faculty member's home Faculty Dean.
