Pre-application workshop checklist

For all questions, “you and your” refers to the student completing the application.

What to bring to the workshop:

Social Security number — Be sure to know your Social Security number, as you may need it to submit your application. If you don't know yours or don't have it, don't worry, we will help you complete your next steps without it.

Application fee — To complete the application, you must pay the application fee online or indicate your eligibility for a waiver.

Driver license — If you have a driver license, great, bring it. If not, that's okay.

Unofficial transcript — To self-report your grades, you will need an unofficial transcript for reference. If you do not self-report your grades, you may need to send an official transcript to the university. Self-reporting your grades allows your application to be processed faster.

Senior year coursework — As a part of self-reporting your grades, we'll also want to know what classes you plan to take in your senior year. Be sure to have your senior year schedule at the ready.

Parent or guardian contact information — It is helpful if you can provide the following information about your parent(s) or guardian(s) on the application:

First and last names.

Relationship to you.

Contact details.

Did your parent or guardian attend this university?

Optional information — The University of Arizona application allows you to list your activities, leadership experiences, clubs and organizations, as well as a personal statement.

What to review before the application workshop

View degree programs — You will be required to select a degree program on your application. If you are unsure of your degree program of interest or would like to know more about degree options, explore [ASU's degree programs](#), [NAU's degree programs](#) and [UArizona's degree programs](#) prior to the application workshop.

Helpful tips: At the workshop

Write down/remember your login information — You will need the username, email address and password used for creating your application if you need to log back into your application.

Use an email account you have easy access to — If possible, use a personal email account instead of your high school account. Make sure the email address is appropriate. The university will correspond with you regarding your admission decision and next steps through this email.

Complete your application

A complete application includes:

- A completed and submitted online application.
- Paid application fee or completed fee waiver built into the application.
- Any additional information requested by the university via your university portal.
