Our transportation program is a free service offered to members of the The Grove at Frisco Commons who reside in Frisco and cannot attend the facility and its functions by any other means.

- 1. Transportation Participant Form** must be filled out and approved by staff prior to being added to the transportation list. This process takes 24 hours before we can add you to the list. Members who live outside of Frisco, those who reside in Frisco temporarily, or those that cannot provide proof of Frisco residency are not eligible for this ride service.
- 2. Rides are ROUNDTRIP ONLY.**
Riders **MUST** ride in on our bus in order to be taken home on our bus. No exceptions.
- 3. Sign up for your rides early: Call 972.292.6550**
Residents may call Monday morning starting at **7:30 am**. There are only 14 seats available on the bus for West and East routes. The schedule is available one week in advance. Do not leave transportation requests on voicemail, you must confirm transportation appointment with a staff member.
- 4. Pick Up Time Range**
We cannot provide a definite time for pickup; each day will vary depending on how many riders are scheduled. You must be ready at the time the bus arrives. Due to the number of clients we serve, we are unable to wait long periods of time at each home (3-4 minutes) max.

WEST RUN- West of North Dallas Toll Road **Approximately 8:00am—9:30am**
EAST RUN- East of North Dallas Toll Road **Approximately 8:00am—9:30am**

FRIDAY
WEST RUN- West of North Dallas Toll Road **Approximately 8:00am—9:30am**
EAST RUN- East of North Dallas Toll Road **Approximately 9:30am—11am**
- 5. Return Home: Please be in lobby 5-10 minutes prior to departure**
Return trips leaves at 1pm on Monday through Thursday. Friday departures are 1pm for West Side and 2:15pm for East Side.
- 6. Cancelling Your Reservation**
Call 972.292.6550 to cancel your ride prior to 7 am. You may leave a message on our voicemail service, if before/after hours. Failure to cancel your ride in advance or NO SHOWS will result in suspension/removal from route.
- 7. Safety Requirements**
While in route, you are required to remain seated with your seatbelt on. Please do not move about the vehicle while in motion. Please respect and follow directions given by drivers. We ask that you keep your voices low to not distract.

- I will notify staff of any address and phone number changes.

Release of Liability

It is further agreed that the execution of this release and acceptance of the same shall not constitute a waiver by the City of Frisco, Texas, and its Releasees, of its/their governmental immunity and/or any other defense it may have at law and/or equity, whether state and/or federal. Acceptance of this release is not to be construed as an admission of any liability whatsoever by any or all of the Releasees. I, further agree to indemnify and defend the Releasees if I am not authorized to sign and legally bind the registrant to the terms of this release or if the person named herein attempts to rescind this release. If any term of the release is deemed void or voidable, it shall not affect the enforceability of anything else in the release. **This Release of Liability Form will be valid and in force and effect for all purposes stated herein for 12 months from the date of execution.**
