## General Planning Comments


Comments should be clear, concise, and relevant to the analysis of the proposed action.

Comments that are solution oriented and provide specific examples will be more effective than those that simply oppose the proposed project.

Commenting is not a form of "voting" on an alternative; the number of negative comments an agency receives does not prevent an action from moving forward.

Numerous comments that repeat the same basic message of support or opposition will typically be responded to collectively.

Unless the relevant causes and environmental effects are explained, stating that an action will have "significant environmental effects" will not help an agency make a better decision
