### Visa Renewal Document Checklist

Please note that you should review the U.S. consulate's website for your home country for the required forms needed, fees, and other requirements. Also, review these [ten tips](#) on what you should remember when applying to renew your visa.

#### F-1 Student/ J-1 Students & Dependents

- ☐ All I-20(s) or DS-2019(s)
- ☐ Passport
- ☐ Official [Transcripts](#)
- ☐ SEVIS [Fee Receipt](#) (click on "Check I-901 Status" button)
- ☐ Documentation of finances, which corresponds to what is listed on your most recent I-20/DS-2019
- ☐ Documents showing your "non-immigrant intent" (i.e. documents which help to prove your ties to your home country and verify that you have no intentions of immigrating to the U.S.)
- ☐ **Graduate Students** - CV/resume, complete list of publications, professional/research references
- ☐ **OPT / STEM OPT Participants** - photocopy of your EAD and job offer letter / proof of employment

#### J-1 Scholars & Dependents

- ☐ All DS-2019s
- ☐ Passport
- ☐ Letter of invitation
- ☐ Documentation of finances, which corresponds to what is listed on your most recent DS-2019
- ☐ SEVIS [Fee Receipt](#) (click on "Check I-901 Status" button)
- ☐ CV/resume, complete list of publications, professional/research references

#### H-1B, O-1, E-3, TN, and H-1B1 Visa Holders & Dependents

- ☐ Most recent I-797 approval notice, if applicable
- ☐ Passport
- ☐ Copy of the I-129 petition, if applicable
- ☐ Copies of Degree Certificates and Certification of Evaluation, if necessary
- ☐ Letter from your department confirming your continued employment
- ☐ Pay Stubs from last 3 paychecks
- ☐ **H-1B, E-3, and H-1B1 visa holders** - Copy of the Labor Condition Application (LCA)
- ☐ **TN visa holders** - Must present their original degree certificates, not copies
- ☐ If applicable, CV/resume, complete list of publications, professional/research references

#### More information about visa renewals

- Processing times vary from country to country
  - Check the U.S. State Department's [website](#) for current wait times and important updates.
- Visa Interview Waiver Eligibility
  - The federal government extended a [policy](#) that authorized the waiver of in-person visa interviews to December 31, 2023 for certain visa categories.
  - Policies vary from consulate to consulate, depending on local conditions, so review the website of the consulate where you plan on applying for your visa for more information.
- Some applications will be subject to security clearances (known as "[Administrative Processing](#)"), which in rare cases can cause delays
  - OIS cannot influence processing times for clearance checks.
