- Circle, but do not correct, errors in spelling, grammar, and punctuation.
- When you return the essay to the author, go over this form together to explain your comments.

## Individual paragraphs

### Introductory paragraph(s)

1. Does the author begin the story with a "**hook**" to grab the reader's interest? What is that hook?

2. (If a clear story is being told vs. a metaphor description) Does the author STOP, BACK-UP and PROVIDE **EXPOSITION** (tell the reader where and when the scene is set, who the characters in the story are, and how the author came to be involved in this situation)?

### **Body paragraphs**

1. Do the body paragraphs move in **chronological order** through the events of the story?

2. Is there a **clear focus for each paragraph** and are there paragraph breaks at logical points, such as change of scene, time, or date? If one paragraph takes on multiple topics they need to fix that.

3. Does the action of the story build to a **clear climax**? Can the reader tell how it is resolved?

4. Are there **transitional sentences** at the beginning or the end of key paragraphs? If not, make a note on the essay where transitions are needed.

---

5. Is there **reflection at each major point in the story** so the reader understands what the author was thinking and feeling as the events unfolded? If not, make a note in the margin of the essay where reflection should be added.

### **Conclusion paragraph(s)**

1. Does the writer explain why this experience is significant to him/her? Has the writer found a way to answer the “so what?” question? If not, how might the author make this idea clearer to the reader?
